



[Release of Liability and Assumption of Risk](#)

The Detroit Cycle Pub welcomes you to this unique and fun experience. In consideration for this experience we requests that you execute this Release of Liability and Assumption of Risk. We also wants to ensure that you understand the rules while riding with us. Thank you for joining us for a cruise around Detroit.

Release and Assumption

I understand that there is a risk of injury, whether caused by me or someone else, in the use of the quadricycle before, during, or after the ride ("Tour"). I understand and voluntarily accept the risks. I agree to specifically assume all risk of personal injury, whether physical, mental or otherwise, as well as risk of any and all loss, theft or damage of personal property before, during, or after the Tour.

I hereby agree on behalf of myself, my children, my parent, heirs, assigns, and personal representative and estate, to release and discharge Detroit Cycle Pub LLC, its agents, owners, officers, members, managers, participants, volunteers, employees and all other persons or entities acting in any capacity on behalf of Detroit Cycle Pub LLC ("DCP"), from any and all claims or actions that I may ever have that may arise or be brought against DCP as a result of anything which occurs before, during, or after the DCP Tour, including but not limited to Injury (including to the person), Loss, Death, Theft or Damage to any person or property, now or at any time in the future whether or not caused by the DCP. I agree to defend, indemnify and hold DCP harmless against any and all claims that may be brought against them by me or brought by others arising out of the DCP Tour.

Rules

I agree to obey the Rules of the Detroit Cycle Pub, and the laws of the State, City, and County in which we ride. I understand that it is not DCP's responsibility or obligation to inform me of the applicable laws, and I assume full responsibility. The Rules for the Detroit Cycle Pub are as follows:

- NO alcoholic beverages may leave the bike at any time, alcohol may not be handed off the bike to passengers or non-passengers
- NO alcoholic beverages other than beer and wine are allowed on the bike
- NO rider may leave the bike in motion, and no one may jump on the bike in motion
- NO disrespect to the community of Detroit, including littering, foul language, obscene gestures, etc.
- NO abuse of the bike, the Booking Individual will be billed for any incurred damage
- NO glass containers allowed on the bike
- NO alcohol is allowed on the Cycle Pub if any single rider is under 21 years of age
- NO hanging off the bike, or reaching off the bike, for obvious safety reasons
- NO public urination
- NO excessive noise or yelling
- NO providing alcohol to non-passengers

Alcohol Consumption

All State, City and County law pertaining to alcohol consumption apply. It is my responsibility to make sure that I follow all laws at all times while on the Tour, including, but not limited to, law regarding public intoxication and public consumption of alcohol. It is my responsibility to never



become intoxicated during the Tour. If I become too intoxicated in violation of law or local ordinance, I will be doing so at my own risk, and I may be asked to leave the Tour.

I understand that DCP will charge the Booking Individual's credit card if DCP is fined or receives an infraction due to a rider's actions. I understand that my name and/or the Booking Individuals name may be shared with the local law enforcement if any infractions occur during the Tour.

Helmet

Helmets are available, if you choose not to wear a helmet you do so at your own risk.
